- 10.0164 Present: Chairperson J Stonebridge, Cllrs J Roe, J Norman, D Rust, M Gatskell, P Jackson, L Kelton, Carlisle City Councillor J Collier and Cumbria County Councillor T Allison
- 10.0165 Apologies from Vice chair W Bolton and Cllr D Murray
- 10.0166 Cllr J Stonebridge Proposed by Cllr J Roe elected unanimously as Chairman
- 10.0167 The Chairman signed the minutes of the last Meeting as a true record

- 10.0171 County Councillor T Allison reported that he would support the erection of a shelter at Boustead Hill by giving the PC a grant of £3,000. The extension of the 30mph limit on the U1124 will be brought to the Neighbourhood Forum. Additional lighting has been put at the West End of the village. A change to the bus services making a circular route (71 and 93) will be pursued by Marie Whitehead at a later date. New Tide markers could be discussed at the Neighbourhood Forum.
